These rules are in effect all year around for all members. Here are some reminders:

- We **encourage bringing guests** as this helps grow our memberships!! Please remember, if they are not a member, they must sign in at the clubhouse. This applies to your children's friends. Guests are only allowed to come once, then they must become a member. This applies to children's friends.
- **Green fees apply** to all guests of members, including your child's friend. If they are not a member, they must pay green fees to play golf.
- **Cart rentals and cart rules** – – carts are only rented to licensed drivers 16 years of age and older. There are some exceptions to this, must see Club Manager for these exceptions ... carts are limited to two people per cart, they may not be operated with multiple people on a cart. There is no standing on the back of the cart, or hanging off of the carts, as this becomes a liability issue for the club. Remove trash from cart when you put it in the garage. ATVs are not allowed on the course, ever.
- Everyone must **practice golf etiquette and follow the rules**. Keep the carts on the cart path, do not drive down the middle of the fairway. Everyone is reminded to use the 90° rule. Replace all ball marks and divots on the greens. Put cigarette butts in the trash and do not spit on the greens! Remember, there will be someone coming behind you! Keep up with the pace of play and let faster groups play through.

Be courteous to all players and remember that golf etiquette applies to all! The Club Manager has the authority to enforce the rules!

- Our **swimming pool is for members only**. Children 12 years of age and under must be accompanied by a parent or guardian. There is not a lifeguard on duty!! Everyone must sign in at the clubhouse if they are going to be at the swimming pool.
- **PCC staff is not responsible for children** left unattended at the clubhouse, pool, or on the golf course. In fact, if a child is under 16 years of age and is playing golf, they must be accompanied by a parent or guardian.

Members and others who have had an encounter on the course, or anywhere on the premises, that is considered inappropriate behavior, should report such to the Club Manager as soon as possible.

Thank you for your cooperation and your understanding. We are looking forward to seeing your families enjoying our course all year long.

In all other cases, **USGA RULES** apply.
